Dear Mrs. Blubaugh:

My wife has referred your letter of March 27 to me for reply, since I am the genealogist of the family. It seems that the Col. Phillip Hoskins--Ann (Matthews) Mudd connection in Charles Co., Md. relates to my wife's Mudd line. There are several references to this in The Mudd Family off The United States, by Richard D. Mudd, M.B.

For your information, in the event that you do not have a copy of this book, I am sending you copies of three pages from the book. In addition, I am listing other information and quoting some excerpts from book, which is in two volumes.

"On 6-17-1710 'Barbary' Mudd of Prince Georges Co., Md. sold property known as "Mudd's Rest" and "Boarman's Reserve", of 200 acres to Thomas Padgett for 6000 pounds of tobacco. Purchaser was given the right of renameing the estates. Witnesses for this transaction were Philip Hoskins and Thomas Short." --Vol. I p. 26

One of the daughters of Thomas Mudd ( the first Mudd in the genealogical line set forth in the above book) was Sarah. The following reference is made to Sarah, the seventh child and third daughter of Thomas Mudd (A): "Sarah Mudd was unmarried as late as 1715 and, as far as is known, died unmarried. On 6-20-1714 Sarah Mudd witnessed the will of Col. Philip Hoskins ( see under "Hoskins Family", below)".

The third wife of Thomas Mudd (A) was Ann Matthews, whom he married c 1685. She (probably) was a daughter of Dr. Thomas Matthews, Sr. and Jane Cockshutt.

"in the will of Ann Matthews Mudd Hoskins (Ann, after the death of Thomas Mudd in Charles Co., Maryland in 1697, married Philip Hoskins, Esq.) the latter refers to her son-in-law 'Mr. Craycroft'. When the inventory of her estate was made William Matthews and John Craycroft were signatories."---Vol. I p. 27

"On 11-14-1698, after the death of Thomas Mudd (A), Ann Mudd( nee Matthews) married secondly Colonel Philip Hoskins. ( See Deeds Liber. X, f 243 and Liber. XW2 ( poss. X#2) f 208, Chas. Co. Md.) Inasmuch as she had five children by her marriage to Philip Hoskins, after having had four children by her first marriage to Thomas Mudd (A), makes it likely that she was young when she married Thomas Mudd. That this Ann Hoskins was a wife of Thomas Mudd (A) is shown by the administration of Co. Philip Hoskins' estate."--Vol I p.31

Children of Thomas Mudd (A) and Ann ( Matthews) Mudd( who later married Col. Philip Hoskins) were:

John b. 1690-95 ( I have more info on him. -- W.G.J.)

Jane

referred to as dau of Thomas Mudd and his last wife

Ann Matthews. Jane m/l 4-10-1711 Nicholas Brent,
second son of Capt. George Brent and .....Greene.
No issue. m/2 probably John Craycroft. The marriage
of Jane Mudd and Nicholas Brent was probably an important social event. The mansion of the Greene family
still stands today as witness of the fine taste of its
pioneer owners. Mrs. John Rascob of our day belongs to
this family. (The father of Nicholas Brent was Capt.
George Brent whose first marriage was to .....Greene
in 1667. His second marriage was to Mrs. Mary (Sewell)
Chandler, dau of Lady Charles Baltimore( Lord Baltimore
the 3rd) (i.e. Jane Lowe Sewell) on 3-27-1687.

Note: Ann married after 8 or 9/19-1706 to Leonard Brooke and had 9 children. ( I have more on Leonard Brooke).

In footnote 98, on p. 46, it states: "In 1721 William Thompson, age 66, deposed that he was married to 'Bennett Hoskins' mother's sister" ( see Chancery Procs. L.3. f. 707, L.O. Annap., Md.). This was corroborated when we found that William Thompson married Victoria, dau of Dr. Thomas Matthews and his wife Jane of Chas. Co., Md. ( See Deeds. L.#1, f. 3, Chas. Co., Md.)

Page 43, of Vol I, carried a footnote no. 121. This footnote reads, "The records of disbursement show that no disbursement was made to the children of Col. Hoskins' last wife by her husband Thomas Mudd (Chas. Co., Md. Adm. Acct's, L. 10 f., 5. H.R. Annap. Md.)

"It is interesting to note that Thomas Mudd (Aa), like his grandfather William Boarman (Note: Sarah Boarman, second wife of Thomas
Mudd (A) was a dau of Major William Boarman and Sarah, possible Singly)
mastered the language of the Indians. It is recorded that on
5-8-1700 payment out of Colonial funds was made to Thomas Mudd (the
money to pay Thomas Mudd was given to Capt. Phil. Hoskins) for having
traveled thirty "miells" to act as an interpreter between a military
officer and the Indians." ---Vol. I, p. 51.

"On 7-20-1724 ( recorded 8-2-1724) Thomas Mudd of Chas. Co., Md.
leased to William McPherson ( spelled Muchferson in the lease) 100
acres of land known as "Brierwood" at the N.E. corner thereof where
Bennett Hoskins "now hath a quarter" adjoining where Thomas Sanders
lives and to land called "St. Matthews". By 1753 William M. McPherson owned 175 acres of "Brierwood'". --Vol. I p. 52

"On 8-29-1797 Joshua Mudd purchased of Mingo( or Mungo) Muschette f & 947-17-3, 6582 acres of property known as "Friendship" which was a part of Hoskin's Manor that Mingo Muschette had purchased from the State of Maryland. Vol. I p. 66

It seems that some of the Mudds and some of the Hoskins went from Maryland to Kentucky and settled in Washington County, and perhaps some of the surrounding counties,

"It is significant that William Mudd of Hardin's Creek (in Washington Co., Ky.--W.G.J.) and Ann Mudd appeared on the Wash. Co., Ky. tax list the same year. This Ann Mudd was taxed in 1804 for two slaves and nine horses; and was listed on the tax records through 1808 always with nine, ten or eleven slaves. Probably she was the Nancy Mudd who was listed in the 1810 Washington Co., Ky. Census. We suspect that she was the mother of William Mudd (Aaea). It is noteworthy that a Nancy Mudd married John Hoskins on 2-19-1813 in Washington Co., Ky. It is significant that neither William nor Andrew Mudd of Hardin's Creek had a noticeable increase in slaves for 1809 although both had a significant increase in 1811, i.e. William from 1 to 6 slaves, and Andrew from 0 (none) to 7 slaves."

William Mudd ( Aad) died in Washington Co., Ky. in 1804. Executors of his estate were his wife Elizabeth ( Clements) Mudd and his son, Richard; and witnesses were Edward Clarkson, William Montgomery and Joseph Hoskins ( also copied Joseph R. Haskins). Vol. I p. 167

"An Elizabeth Mudd married Joseph Milburn Simms in Prince Georges Co., Md. on 2-10-1790. We believed for many years that she was the daughter of Francis Mudd (Abag), but finally concluded that she could not be ( see account of Abagc). It is possible that she was a daughter of Richard Mudd (Abab). Items regarding Joseph Milburn Simms ( or Semmes) are as follows:

"Joseph M(ilburn?) Semmes and William Neale inventoried the effects of Mary Hanson, widow of Major Sam Hanson (Ref. 122 p. 236). The latter was the son of Robert Hanson and (probably) Mary Hoskins, daughter of Col. Philip Hoskins the husband of the second wife of Thomas Mudd (A) (Ref. 122, pp 224 and 234)." p. 562 Vol. I.

In reference to (Dr.) Joseph Mudd (ABAF):

"IDENTITY OF DR. JOSEPH MUDD'S SECOND WIFE: John Hill who made his will in 1800 (Prince Georges Co., T. 1, 453) had sons Clement, Philip, and Richard and daughters Elizabeth and Ann. Inasmuch as Elizabeth Hill Mudd, wife of DR. Joseph Mudd had a sister Ann Hill Magruder it seems quite obvious that Elizabeth Hill Mudd was a daughter of John above. It is said that Jane Hill, daughter of Ann Hoskins and Henry Hill (d. 1796), son of Clement Hill, Jr. (b. Eng. 2-24-1670) and Ann Darnall (d. 3-26-1749) married \_\_\_\_Mudd."

Note: Dr. Joseph Mudd (ABAF) studied medicine in the Universities of Paris, France and Rome, Italy. It was suspected that he migrated to Kentucky, but this could hardly have been the case. He may have visited in Ky.

Foot note 8 on p. 857 states that "Ann Hoskins was the daughter of Oswald Hoskins. Ann Haskins also given."

"Beginning in 1753 (first available year for the debt books) until the death of John Mudd (Ad) he remitted quit rents on 180 Acres of "St. Catherines". John Mudd's land was apparently adjacent to that of Ignatious Gardiner's.

"Philip Hoskins who married the widow of Thomas Mudd (A) claimed a

third of "St. Catherines" as his wife's dower. See depositions of John Smith ( of Jordan) and 6-8-1772 who stated that about fifty years ago he was in possession of St. Catherines when Col. Hoskins made the claim. p. 1142

The Mudd Book discusses several "Unplaced Mudds". This reference is to Unplaced Mudd # 11.

"Henry Hill, Sr. ( of Clement Hill and Ann Darnell) m. Ann Hoskins daughter of (probably) Oswald Hoskins. ( However Col. Philip Hoskins and Ann Reeves also given as her parents.) ( See "Across The Years in Prince Georges' Co., Md., Effie Gwynn Bowie( 1947 p. 428)).

The above concludes all the references I could find to the Hoskins Family in the Mudd Book. Just about the time we received your letter I had planned to check the Washington County records for information of interest to a lady who had been helping me on one or two of my lines. So, in doing this I made note of all instances in which I found the Hoskins name in the records which I looked at. The following notes are from the Index of Washington County Deeds, the Washington County Marriage Licenses and Bonds, and Washington County Tax Lists.
